5. Discussion Items

A. RapidDeploy / GeoComm Presentation

Brooks Shannon and Greg Brooks from RapidDeploy and Dan Craigie from GeoComm made a presentation to the committee demonstrating the RapidDeploy Radius Mapped ALI application that includes support for enhanced text tools and wireless enhanced location. RapidDeploy also offers 911 system metrics capture and reporting. These tools are being deployed statewide in several states including California and more recently in Tennessee. They also demonstrated what indoor caller location mapping looks like. Marcia Broman said that the data sets Brooks was explaining are regional data sets.

B. T-CPR Training Compliance Letters

Eggimann reminded members to get compliance letters into ECN by Friday, July 16.

C. Mental Health Call Processing Standard

Martin said the Chiefs of Police and Sheriff's Association continue to meet. The PSAP sub-committee is seeking smaller PSAPs to do a presentation on their program. Martin will be asked to present their pilot program.

Martin said the next phase will be working with the city and adding some grants.

Darlene Pankonie said in the omnibus bill for Public Safety there is an item called Travis' Law. That law passed. This law says the PSAPs taking mental health related 9-1-1 calls are obligated to refer those calls to a mental health crisis unit where available. There is no guidance on what "referral" means or on "where available". Pankonie said she felt it would be in our best interest to develop some recommendations on how PSAPs can comply with this new requirement.

Haas said this topic was on the MSA/Sheriffs call yesterday. The MSA lobbyist said this bill creates a fourth-tier response under 9-1-1. The lobbyist did ask NAMI for more clarification on what "where available" means.

Haas said MS Chapter 403, Subdivision 1 was amended to add paragraph b. "In addition to ensuring an appropriate response under paragraph a., the 9-1-1 system shall include a referral to a mental health crisis team where available".

Pass said it is her understanding that once 9-8-8 is available, crisis teams should be available to respond state-wide.

Pankonie said NAMI was fully aware it was loosely defined.

D. 9-1-1 Telecommunicator Pension Work Group – Survey

Pankonie said the first meeting will be on July 30th. Pankonie will be representing APCO/NENA. Tim Boyer and Mark Lallak from Itasca County are also in that group.

Bowler asked if it was known what employees would fall under the group that would qualify for pension benefits. Pankonie said that remains to be seen.

E. Legislation Update

Pankonie said the 9-1-1 Telecommunicator Working Group was formed and per legislation of this omnibus bill, the Commissioner of Public Safety is tasked with securing members by July 30th. The Commissioner will finalize the appointments by August 15th and the first meeting must be convened by September 15th. Fifteen entities need to supply a member. A report from this work group is due by January 13th, 2022. The pension report is due to the legislature in March.

Haas asked if there was language that designated a non-supervisory appointee. Pankonie said it did not state non-supervisory.

Rohret said the recommendation would not come before the MESB for approval until the September board meeting.

Bowler said it is in the best interest to come up with a recommendation at this meeting.

Pankonie said the tasks of the re-classification work group would be to recommend a statutory definition of 9-1-1 telecommunicators, recommend minimum training and continuing education standards for certification, recommend standards for re-certification, recommend funding options for mandated 9-1-1 telecommunicator training, recommend best practices and incident response command structure for the state's first responders to implement, and provide other recommendations the working group deems appropriate.

Membership of the group can be found in Subdivision 1. of the 9-1-1 Telecommunicators Working Group Statute.

Rohret said group should be thinking of a supervisory and a non-supervisory appointees until the membership requirement is defined. The definition for non-supervisory is to be within the seven counties.

Motion made by Janelle Harris to nominate LaVae Robinson as the MESB representative to the 9-1-1 Telecommunicator Re-Classification Work Group. Bob Shogren seconded. Motion carried.

A. Recommend Representatives for the 9-1-1 Telecommunicator Working Group

Jill Rohret reported the MESB had now received the request from ECN to make two appointments to the 9-1-1 Telecommunicator working Group. The first appointment calls specifically for a representative for the MESB. The second is for a representative for the metro region, as one of the seven regions in the state. The 9-1-1 TOC was not asked to specifically nominate someone for a non-supervisory role from the metro region, as was discussed at the meeting last week.

Pankonie said that at yesterday's SECB NG9-1-1 Committee meeting the question came up asking who was nominating, "(b) The working group must also include a nonsupervisory telecommunicator working in a regional center outside of the seven-county metropolitan area, a nonsupervisory telecommunicator working in rural Minnesota, and a nonsupervisory telecommunicator working in the seven-county metropolitan area"?

Pankonie said she told Director Wahlberg she thought the NG9-1-1 Committee had been requested to make those recommendations and that there were already letters submitted to the Commissioner.

Director Wahlberg said it was never ECN's intention to request that the NG9-1-1 Committee make those recommendations.

Pankonie said that she interpreted the request to convey that the 9-1-1 TOC could make those recommendations, or the committee could send all the names of people who submitted letters of interest to the Commissioner to assist him in making the selection.

Pass asked if a commissioner on the MESB Board could be appointed to that committee? Rohret said she conferred with the MESB Chair Joe Atkins, and he said the Board supported the 9-1-1 TOC to make the recommendations.

Shogren asked if recommendations could be made to all three; a nonsupervisory telecommunicator outside the seven-county metro area, a nonsupervisory telecommunicator inside the seven-county metro area, and a nonsupervisory telecommunicator working in rural Minnesota.

Pankonie said she thought yes, the 9-1-1 TOC could.

Vadnais asked what would happen if the other entities do not deliver a nominee?

Pankonie said that is unknown.

Eggimann said he received an email from Tim Boyer of Minnesota State Patrol that they had been asked to submit two names and they have already done that. One of which had also submitted a letter of interest to the MESB.

Eggimann said in initially communicating to the group to have letters submitted it was not conveyed that it could also be a supervisory nominee. This group does not need to be constrained by just the people on this list. As far as the process is concerned, he recommends that nominations are made and voted on for the MESB representative and for the representative for the metro region, as one of the SECB's seven regions.

Pankonie suggested one of the representative nominations be a supervisor and the other nomination a person in a nonsupervisory role.

Haas asked if the board was going to make a nomination? Rohret said the board has asked that this committee make the recommendations.

Shogren nominated LaVae Robinson for the MESB representative recommendation. Vadnais seconded. Motion carried.

Pankonie said she spoke with Tim Boyer. Boyer has provided his commander with two names, John Polz and Nicholas Selzer.

Pankonie nominated Katie Solander for the regional representative. Martin seconded.

Hodne nominated Amy Sizer for the regional representative. Harris seconded.

Shogren nominated Ester Hauss for the regional representative. Sprynczynatyk seconded.

RECOMMENDATION

The Radio TOC recommends including the following items as regional funding priorities for grants available in 2021 (in priority order):

- Communications Response Task Force (CRTF) training/exercise
- Assistance to attend the 2021 Public Safety Communications Conference
- Creation of an updated ARMER training video
- Purchase of laptop radio consoles to be used throughout the region
- Funding local Bi-directional amplifier (BDA) requests

BACKGROUND

Emergency Communication Networks (ECN) Division and the Statewide Emergency Communications Board (SECB) require regions to annually approve regional funding priorities. These priorities are to include projects/items/concepts for which regions can apply for grant funds through the SECB process. In the past, grants were only open to radio projects.

Mental Health Call Processing Best Practice

Objective

To develop a mental health call processing best practice for the metro area. To define the expectations of the role provided by mental health partners.

Background

Recent developments with law enforcements involvement with mental health callers has created a need for intervention at the 911 level where available. State legislation has changed stating that "the 911 system shall include a referral to mental health crisis teams, where available."

Definition

A mental health crisis is any situation in which a person's actions or behaviors may lead to them hurt themselves or others, and/or put them at risk of being unable to care for themselves or function in the community in a healthy manner.

A crisis can be defined as an unstable situation with an uncertain outcome in which an individual's coping capacity is temporarily overwhelmed.

Operational Context

Outlines best practice for PSAP responsibilities for handling mental health callers.

Recommended Operation Best Practice


- 1. Each PSAP should have a documented process for handling mental health callers, where available.
- 2. Call takers should understand department protocol for assessing mental health calls. Utilizing a decision tree can provide guidance to assess if the caller meets criteria.
- 3. A mental health call handling process should not be a barrier to a caller that is asking for an Emergency Medical Service (EMS) response.

Text-to-9-1-1:

Washington Co. is the only remaining primary PSAPs in the metro area that has not yet implemented text capabilities on their answering applications. Washington plans to implement text messaging concurrent with their 9-1-1 answering application upgrade. Installation work is now underway is expected to be complete by the end of September.

NG9-1-1 ESInet:

The NG9-1-1 ingress system implementation is underway. Inteliquent has identified the point of interconnect (POI) locations across the state with two legacy telephone POIs in each LATA. This will make it easier for the legacy telephone companies to connect to the 9-1-1 system and reduce network costs. Inteliquent will also have two SIP POIs for telecommunications service providers who have IP-based systems capable of delivering 9-1-1 calls to the system as SIP calls. Contract negotiations and design work with Lumen are taking place to get the Inteliquent network connected to the Lumen peering points for the current 9-1-1 system on an interim basis, until the NG Core Services vendor is selected.

Additional work remains for the MESB and ECN on the RFP(s) for NG9-1-1 core services and 9-1-1 system egress connectivity between the core services and the PSAP. ECN has contracted with Federal Engineering for professional and technical services to assist in the RFP process. The MESB has contracted with 911 Authority for professional and technical services to also assist in the core services and egress RFP process.

The MESB continues to focus on giving our PSAPs better continuity-of-operations (COOP) options as well as enabling workload sharing for the PSAPs that are interested in working together. We want to ensure that our ESInet infrastructure can support shared/hosted and cloud-based applications and not limit the use of the ESInet to just handling 9-1-1 traffic. We are working now with ECN to consider ESInet options that would rehome our PSAP ESInet connections to redundant, diverse datacenters that can become the hubs for delivery of shared/hosted and cloud-based applications to all the metro PSAPs such as CAD, CAD-to-CAD interoperability, logging, as well as 9-1-1 answering applications.

In April 2018, NENA published a new NG9-1-1 ESInet Design document that outlines new modifications to the existing ESInets in use today. The new design focuses on increasing reliability and resiliency by incorporating multiple network service providers using different network protocols (e.g. MPLS, Ethernet, cable broadband Internet, wireless carrier broadband Internet). The MESB will continue to work with ECN to develop an implementation strategy to bring the metro area ESInet configuration into compliance with the NENA design recommendations.

Metropolitan Emergency Services Board 9-1-1 Technical Operations Committee 9-1-1 Data Report August 19, 2021 Meeting

- 1. Importance of GIS for 9-1-1: PSAP managers are strongly encouraged to continue to assist their GIS counterparts in communicating to key decisionmakers and county leadership what a vital role GIS has to their current and future PSAP operations. Geospatial datasets provide foundational data for PSAP CAD/mapping systems and future NG9-1-1 core services, as well as support many other non-public safety uses that are important to cities and counties.
- 2. Wireless Location Based Routing: As of 7/21/21, all metro area PSAPs are activated for T-Mobile's location-based routing (LBR) capabilities. The LBR method uses the device-based location and PSAP boundary polygons, rather than cell site/sector, to make call routing decisions. The overall goal is to achieve more precise routing of wireless 9-1-1 calls, thereby reducing any delays introduced by PSAP-to-PSAP call transfers. Since LBR has been activated across all metro area PSAPs, approximately 71% of T-Mobile 9-1-1 calls have met the requirements to be routed using LBR (e.g. operating system level, timing, etc.) Although results vary by PSAP, T-Mobile estimates show on average a 12.5% reduction in call transfers across the metro area.
- 3. Wireless Data Audits: TMobile has been delayed in loading the corrections MESB supplied them from the audit conducted on legacy Sprint LTE cell site/sector wireless data.

4. Statewide GIS Data Standards:

- a. Discussions on a **polygon standard for the exchange of 9-1-1 emergency service boundaries** (PSAP, ESZ/ESN, and response agency) continue at a state level.
- b. The NG9-1-1 Committee will be coordinating the circulation of a proposed domain list of **normalized/standardized response agency names** to be used in the GIS data. This is needed for the statewide polygon standard. PSAPs will be asked to review that list and confirm that all agencies they dispatch for are included and there are no significant concerns with the proposed naming that would be used in the GIS data. A similar domain list of PSAP names will also need to be finalized.

5. Vertical location on wireless 9-1-1 calls:

- a. The new ALI format that transmits to the PSAP z-axis information provided by wireless carriers is available for any PSAP that would like to update their ALI format to receive this information. Jake Jacobson at Lumen will schedule and coordinate the change. PSAPs will also want to coordinate with their PSAP CPE and CAD/mapping vendors in advance of scheduling the change because the update will change the ALI data stream format interfacing into those systems. RCECC plans to upgrade to the new ALI format in September.
- b. MESB receives daily **ALI logs reflecting z-axis information available on wireless calls** even if it is not yet being delivered to PSAPs via the new ALI format. This information can be made available to any PSAP that is interested.
- c. **NENA's 3D Geomatics workgroup** is developing a guidance document on the topic of three-dimensional 9-1-1 call location data (x, y, and z-axis). Vic Barnett from RCECC is representing the metro region on that workgroup. PSAP managers will be apprised when NENA's document has been approved for public review.

6. Statewide NG9-1-1 GIS Project:

- a. The SECB Steering Committee is continuing to discuss how to proceed with implementing the NG9-1-1 GIS Workgroup's recommendations for the statewide NG9-1-1 GIS project.
- b. ECN and 1**Spatial** are working to stand up their solution and validation tools. The initial rollout is currently anticipated to be sometime in September. As more information becomes

available, MESB will monitor where and how the 1Spatial solution can complement the regional NG9-1-1 data processes.

ONGOING ACTIVITIES

7. Regional NG9-1-1 Data QA/QC and GIS-derived MSAG activity:

a. **NG9-1-1 QA/QC support:** MESB's error vetting and remediation support to the PSAP/counties is focusing on areas that have not yet made a significant stride toward GIS-derived MSAG transition, as well as other data inconsistencies found through the GeoComm NG911 validations.

b. Current GIS-derived MSAG status:

- i. *Complete:* Chisago County, Dakota County, Anoka County, Eden Prairie, St Louis Park, Edina, Bloomington, Ramsey County, Isanti County, Hennepin Sheriff (partial set of communities)
- ii. *In preparation stage at MESB*: Carver County, Hennepin Sheriff (additional communities)
- c. **Proactive 9-1-1 call location audits** continue for the 10-county region once a week using ALI retrieval logs and the metro regional road centerline, address point, and MSAG data. This process has been helpful in identifying needed VoIP service provider data remediations, as well as some address point additions.

8. ECN NG9-1-1 Federal Grant work:

- a. *Metro Regional GIS-derived MSAG Processes:* MESB staff is using GeoComm's Data Hub to perform supplement NG9-1-1 validations on the regional data. MESB reaches out to county GIS staff and PSAP data contacts as needed for dataset adjustments after reviewing the validation results.
- b. **Sherburne County:** GeoComm continues to edit Sherburne County's data for NG9-1-1 readiness under their grant project.
- **9.** Wireless Cell Sector/Routing Data: MESB processes wireless routing updates for all carriers on behalf of the metro PSAPs. Should PSAPs want the routing for a specific cell sector or 9-1-1 call reviewed, just email *mesbgis@mn-mesb.org* and MESB staff will investigate.

10. Regional GIS Data Aggregation:

- a. **Road Centerline and Address Points:** The MetroGIS/Met Council processes regional road centerline and address point dataset updates nightly to the MN Geospatial Commons website. Each metro county's most recent centerline and address point data that has been uploaded to the portal and passed validations is included in the regional datasets. The regional road centerline and address point datasets comply with the current MN Geospatial Advisory Council (GAC) data standards.
- b. **Boundary Polygons:** MESB maintains the regional PSAP, ESZ, MSAG community, law, fire, and EMS boundary polygon layers in coordination with the PSAPs. These datasets are updated as boundaries change or at a minimum of quarterly. Mobile Positioning Center, Text Control Center, and VoIP Positioning Center vendors are directed to the MN Geospatial Commons for downloads of metro's PSAP boundary polygons.
- 11. Regional Data Viewer: The datasets pertinent to regional 9-1-1 interests are available in the dataviewer developed by MetroGIS/Met Council. (https://www.metrogis.org/projects/9-1-1-Data-Viewer.aspx.) PSAP MSAG coordinators are encouraged to use the dataviewer as a resource for geospatial data their county GIS departments consider valid and current for regional 9-1-1 use.
